## REGISTRATION FEE INFORMATION

- ◆ Registration is due upon entry and each year thereafter in March / April.
- ◆ Registration Fees are non-refundable.
- ◆ Registration Fees include: office records, student accident insurance, consumable supplies, and ACSI membership.
- ◆ If a deposit was paid to be placed on a waiting list, the deposit amount will be applied to the Registration Fee.

## TUITION INFORMATION

- ◆ Tuition fees effective June 15, 2009.
- ◆ When establishing multi-child tuitions, your oldest child is the “first child” in our system with the exception of an infant in infant care, in which case the infant is considered the “first child.”
- ◆ No additional discounts other than those mentioned are available.
- ◆ Tuition is a weekly fee.
- ◆ **Tuition is due on Mondays.** Payments received after 12:00 PM on Wednesdays will be assessed a late fee.
- ◆ Cash, checks, or money orders will be accepted in the school office. Do not leave cash with teachers.
- ◆ A service charge of \$40.00 will be assessed for each NSF check that is issued to the school. All checks physically returned to us by the bank have had two attempts made to be cleared, thus resulting in a total of \$40.00 in fees. After two returned checks, cash or money orders only will be accepted for future payments.
- ◆ We also accept Visa, MasterCard, and Discover. A \$7.00 convenience fee applies per transaction.
- ◆ Receipts for tuition payments are available upon request.
- ◆ Tuition can be paid up to 4 weeks at a time, in advance.
- ◆ Upon enrollment, first and last weeks’ tuition is due and is non-refundable.
- ◆ The last weeks’ tuition will be applied with 2-weeks written notice of withdrawal.
- ◆ Tuition accounts must be kept current in order for a child to remain in the program.
- ◆ A fine of \$1.00 per minute for late pick-up after 6:00 PM will be assessed and due with the next tuition payment.
